And that's the income statement, if you will, 6 7 for the next 18 months, showing what we would like to spend and what we anticipate 8 9 the revenues being. The deal just challenged and charged to only approve a 10 11 budget that you can fund. You can only fund a budget with your anticipated revenues and 12 13 the cash that you have on hand. You're not allowed to spend more than you're going to 14 15 bring in or have in terms of cash in the 16 next 18 months, and that's what this 17-line 17 4B shows for each of those five funds. It 18 is the Trustee's request that you entertain 19 a public hearing this evening and entertain 20 adoption on October 15th. CHAIRMAN LAY: Okay.
